This is for information of all concerned that for fast tracking and early disposal of maintenance proceedings u/s 125/127 Cr.P.C., following Action Plan is adopted by the Courts.


**Action plan.**

- Giving priority to such cases and to give short dates.
- At the stage of recording of evidence, consecutive dates shall be fixed, wherever possible, so that more numbers of witnesses are examined at a lesser period.
- At least 3 to 4 cases of such nature shall be listed per day.
- At the time of registration of the case, the filing of the steps of notice should be mandatorily taken so that delay can be avoided at all level.
- One week special drive commencing from 2<sup>nd</sup> of May, 2013 to 8<sup>th</sup> of May, 2013 shall be taken wherein as much as cases of such nature, in various stages, shall be posted in that week.

**Object of the Special Drive and Target.**

- The object of the special drive is to sensitize ourselves, i.e. Judicial Officers, in respect of the need of speedy disposal of cases of such nature.
- To sensitize, make aware and motivate the other stake holders like Advocates, litigant public, witnesses about the need of speedy disposal of such cases.
- The target is to examine 30 (thirty) witnesses per Court in that week and a total estimated target to examine 120 (one hundred twenty) witnesses, in the said week, by the existing four functional Magisterial Courts including the Court of S.D.J.M.(M) Majuli.
- The ultimate target is to make zero pendency of all the proceedings u/s 125/127 Cr.P.C., registered in the year 2012 or earlier, by August, 2013.
