Further, the candidate so applying shall have to give along with his/her application, a declaration that no Criminal and Civil cases are pending in any Court and no disciplinary proceeding is pending in the Bar Council against him/her.

The candidates are hereby notified that they shall have to appear for the Viva Voce test before the Selection Committee on 28.09.2021 from 03.00 P.M. onwards in the Office Chamber of the undersigned; and, for which no separate Call Letters will be issued to them.

In view of the guidelines issued by the Rules, the candidates will be tested by the Selection Committee about their knowledge regarding Code of Civil Procedure, Indian Evidence Act, Civil Courts Rules and Orders of Hon'ble Gauhati High Court and General Aptitude and this test will consist of 30 (Thirty) marks.
