

MINUTES OF THE MONTHLY MEETING OF THE JUDICIAL OFFICERS WITH THE DEPUTY COMMISSIONER, JORHAT AND SUPERINTENDENT OF POLICE, JORHAT FOR THE MONTH OF JULY, 2016 HELD ON 13/07/2016.

In compliance of the Notification of Honourable Gauhati High Court (Notification No.52 dated 20/08/2013), monthly meeting, for the month of May'2016, was held on 13/07/2016 in the Office Chamber of District and Sessions Judge, Jorhat. The honourable District and Sessions Judge, Jorhat, the Addl. Deputy Commissioner, Jorhat, Additional Superintendent of Police, Jorhat and other Ld.Judicial officers of Jorhat have attended the meeting and discussed/consulted on the following matters.

1. The Hon'ble District and Sessions Judge, Jorhat pointed out that the crime conference needs to be organized urgently which is very much necessary to keep the police up to date regarding the latest changes in law and to point out various lapses during investigation. He also pointed out that the matter has been discussed several times in the past monthly meetings and has already getting delayed to which Addl. Superintendant of Police assured that he will take up the matter and intimate the date and time after discussion with Superintendant of Police, Jorhat.
2. The Hon'ble District Judge, Jorhat enquired about the appointment of extra hand to assist the present employee in the malkhana to which the Addl. S.P, Jorhat told that perhaps the same has been implemented and would confirm the same.
3. The Hon'ble District Judge, Jorhat discussed with the Addl. Deputy Commissioner, Jorhat to make necessary arrangement to cut the branches of the trees in the court building which are inclining towards the electrical lines which may endanger the public lives and may cause massive damage to the court building, Jorhat during some natural calamities/raining season.
4. The District Judge also requested the Addl. Deputy Commissioner, Jorhat to make necessary arrangement to put around 10 dustbins in the court building Jorhat under some related scheme to which the Addl. D.C replied that he would do the needful for the same.
