Proceeding of weekly meeting of Judicial Officers of Jorhat District Judiciary, held at 4.30 pm, on 05.05.2022.

(Learned officers from Titabar and Majuli joined through Video Conference.)

Agenda Items:

1. Discussion on old pending cases:

Discussion was held on disposal of old pending cases in all the courts. More specifically cases which are more than ten years old. Special endeavour should be there from the learned presiding officers to dispose of the cases which are pending at the respective courts for more than ten years. Cases which are pending for more than five years are to be identified and marked distinctly in red colour either through cover page or by tying with a red colour ribbon as per convenience of the presiding officer so that these files can be easily noticed. One or two such old pending cases can be taken up and discussed in the next weekly meeting as a case study to figure out the hindrances while disposing such old pending cases.

2. Discussion on upcoming National Lok Adalat:

In the second agenda discussion was made in regard to the upcoming National Lok Adalat to be held on 14th May 2022. Officers have informed that necessary steps have already been taken and at the same time pre-sitting Lok Adalat is already going on almost in all the courts.

3. Inauguration of new Court at Majuli:

In the third agenda discussion on inauguration of new court at Majuli was discussed which is supposed to be inaugurated on 8th May 2022 subject to final approval from the Hon'ble Gauhati High Court. Various committees have already been formed to look after the entire event. The committees will organize separate meetings for smooth functioning of the event , will take resolutions on respective issues and to inform Hon'ble District and Sessions Judge, Jorhat for approval. Most of the matters have already been taken up with the Deputy Commissioner of Majuli, for necessary arrangement in the inauguration program.

4. Uploading order and judgment in the district Judiciary website:

In the last agenda discussion was made on uploading of orders and judgment in the district Judiciary website. Though orders and judgments have been uploaded in the CIS but the same is not reflected in the district judiciary website. Hence, all the presiding officers will ensure uploading of judgments and orders in the Jorhat District Judiciary website, with the help of system officer, Jorhat.
